

**REQUEST FOR DECISION: PCC 2018 - 13** 

Title of Report: Contact Management Programme Budget Uplift – Sept 2018

## **Executive Summary:**

Continued instability during final Acceptance and Infrastructure Testing of the Contact Management Platform (CMP) for Hampshire Constabulary (HC) and Thames Valley Police (TVP), has resulted in the Programme pausing testing to enable ICT to investigate the reasons for the on-going stability issues.

With investigation now completed, the proposed remediation activity to resolve the underlying causes of the instability and restore confidence in the infrastructure cannot be absorbed by the Programme and has resulted in the presentation of two revised plans for Go-Live (Plans A & B) and their associated costs, together with the estimated impact and costs of progressing with an alternative solution (Plan C).

After presentation of options to the Programme Board and both Force Chief Constables and Deputies, a recommendation has been agreed to progress with Plan A – a remediated environmental approach including a full rebuild of Production. This approach does result in delay to Programme Go-Live and an associated increase in costs.

This approach was presented, together with the alternate options, to both TVP and HC PCC's at the TVP/HC Collaboration Governance Board on 30 July 2018.

A decision is now required to formalise the Force's recommendation to continue the Programme as per the revised Plan A

A further Decision is required for joint approval of the Historic Budget Decision.



## Recommendation:

## The PCC is asked to:

- 1. Acknowledge and approve the joint historic budget position Total Associated CMP Project Budgets to date of £34.5m.
- 2. Approve the additional joint funding request budget for recommended Option A of £7.3m which includes contingency of £1.5m lifting overall approved CMP budgets to £41.8m

This includes specific TVP funding decisions of:

- a) TVP PCC to approve the virement of £1.328m existing and approved revenue budget to support the capital project.
- b) TVP PCC to approve both the core £1.85m new capital required and the additional £0.822m contingency total of £2.672m from the Optimism Bias Reserve.
- Approve the Milestones and Risk Mitigation Gates detailed below as the means to track Programme Progress. Any change to the milestones is to be approved via formal Programme Board Change Control to include PCC representation as appropriate.
