

### **REQUEST FOR DECISION - PCC 2020 / 014**

Title: Contract for the supply of Geospatial Mapping and Address Software Licences to Thames Valley Police and Hampshire Constabulary

Thames Valley Police and Hampshire Constabulary have a requirement for mapping, search and geospatial analysis/data sharing across the Forces to meet existing and emerging needs. The software that will meet this requirement is primarily used with the Contact Management Platform (CMP) and the Corporate Mapping System (CMS). This product will become the single and only mapping and gazetteer product for both forces, replacing obsolete applications and saving costs.

Full details are provided in Annex 1.

#### Recommendation:

The Police and Crime Commissioner is invited to agree the award of contract in respect of the above to ESRI UK (Ltd).

The above contract is for an initial term of 36 months duration with no extension options.

The total value of this contract is estimated at £1.72 million over the full project period. The licencing costs will be split between Thames Valley Police and Hampshire Constabulary using the pre-agreed ratio of 55:44 (Being £0.957m TVP: £0.763m Hants)

### **PART 1 – NON-CONFIDENTIAL**

# 1 Introduction and Background

- 1.1 Thames Valley Police and Hampshire Constabulary have a requirement for mapping, search and geospatial analysis/data sharing across the Forces to meet existing and emerging needs. The software that will meet this requirement is primarily used with the Contact Management Platform (CMP) and the Corporate Mapping System (CMS). This product, provided by ESRI, will become the single and only mapping and gazetteer product for both forces, replacing in due course, obsolete applications and saving costs.
- 1.2 CMP is dependent upon ESRI ArcGIS Server to display incident location and resource availability so that the appropriate officers can be deployed to urgent and immediate grade incidents. CMS will become the primary geospatial tool used by both force and regional intelligence units to plot and analyse crime and incident patterns.
- 1.3 ESRI products have been utilised within TVP and HC since 2015 and the existing licences are due for renewal. The usage of ESRI licences has grown significantly since 2015, with spend increasing from £1.37 million over a three year period to a new proposed contract cost of £1.722 million for the same future time duration.
- 1.4 The new Enterprise Licence Agreement provides new mapping capabilities for exploring new opportunities driven by digital policing and Digital Investigation and Intelligence functions such as plotting Drone data and crime insight analysis.
- 1.5 Full details are provided in Annex 1

### 2 Issues for Consideration

- 2.1 As a result of the technical dependency of CMP and CMS on the ESRI geospatial and mapping applications, no alternative suppliers could be pursued. It was therefore decided that the existing licences with the current supplier be renewed.
- 2.2 In order to progress with the procurement process for this renewal, it was determined that the Enterprise Licensing Agreement could be procured through a Direct Award under RM3871 Data and Application Solutions Framework where there are pre-agreed Cabinet Office terms and conditions that can be accessed. This not only would reduce the administration required to develop terms and conditions but also give Force's confidence that the terms and conditions are of a robust nature. Unfortunately, the ESRI Ordnance Survey Point of Interest data licences cannot be procured via the Direct Award under RM3871, as there is no provision for third party data licence terms. As such, the recommendation is to procure these data licenses (circa £100K) directly via a Single Source Action.
- 2.3 The suppliers meet all the requirements of the contract terms and conditions and specification and offer the Most Economically Advantageous Solution, as assessed through the evaluation process.

#### 3 Financial Comments

3.1 The total cost is estimated at £1,722,387 for the full 3 year period with no optional extension periods. This is comprised as follows:

This represents a 26% increase in spend over the current cost.

- 3.2 The licensing costs will be split between TVP and Hampshire Constabulary using the pre-agreed ratio of 55:44 (TVP £956,882, Hants £765,505)
- 3.3 The Consolidation of multiple license renewals into one Enterprise License Agreement will lead to a reduction in renewal administration. Furthermore, the consolidation of all licensing into one agreement will result in greater emphasis on contract management through quarterly service delivery review meetings and an annual governance review meetings.
